The selection board may shortlist candidates after written test to the extent of ten times the number of posts for skill/Practical test. All tests, Skill/Practical test will be conducted at Rashtriya Military School Belgaum, Camp Area, Belgaum-590 009. The question papers of Written Test will be bilingual i.e., English & Hindi. However, the questions on the portion of English Language subject will be in English only.

6. Syllabus for Examination

- (a) <u>General Intelligence:</u> The question will be of 10th Standard & would include questions of non-verbal type. The test may include questions on analogies, similarities and differences, space visualization, problem solving, analysis, judgment, decision making visual memory, discrimination, observation, relationship concepts, figure classification, arithmetical number series, non-verbal series. The test will also include questions designed to test the candidate's abilities to deal with abstract ideas and symbols and their relationship, arithmetical computation and other analytical functions.
- (b) General Awareness: The question will be of 10th Standard. The questions will be designed to test the ability of candidate's general awareness of the environment around him/her and its application to society. Questions will also be designed to test knowledge of current events and of such matters of everyday observation and experience in their scientific aspects as may be expected of 12th standard for LDC post and 10th standard for others post. The test will also include questions relating to India and its neighbouring countries especially pertaining to Sports, History, Culture, Geography, Economic Scene, General Polity including Indian Constitution and Scientific Research etc. These questions will be such that, they do not require a special study of any discipline.
- (c) <u>Numerical Aptitude:</u> This paper will include questions on problems relating to Number systems. Computation of Whole Numbers, Decimals and Fractions and relationship between Numbers. Fundamental Arithmetical Operations, Percentages, Ratio and Proportion, Averages, Interest, Profit and Loss, Discount, use of Table and Graphs, Mensruation, Time and Distance, Ratio and Time, Tim and wok etc..
- (d) <u>English Language:</u> The question will be of 10th standard. Candidates understanding the Basics of English Language, its vocabulary, grammar, sentence structure, synonyms, anonyms and its correct usage his/her writing ability would be tested.
