- (i) In respect of candidates having experience in reputed Museums in the relevant areas of the post, the age limit up to the number of years of their experience, which shall not however exceed the maximum period of five years, is relaxable by the Salar Jung Museum Board on the recommendations of the Selection Committee.
- (ii) Mere fulfilling the minimum prescribed qualifications and experience will not vest any right in a candidate for being called for interview. After completion of the process of screening of the applications, short listing of applicants will be done in the order of merit by giving preference to those who possess higher qualifications, experience and call letters will be sent. The decision of the Museum in this regard shall be final.
- (iii) Candidates already in service of Government/Quasi-Government /Institutions or Public Sector Undertakings should apply through proper channel in duplicate. Applications not forwarded through parent organization along with requisite documents will not be considered.
- (iv) The forwarding / endorsing authority shall send he applications in respect of the applicants who can be spared in the event of his/her selection. If the application is for deputation, complete up to date ACRs of the applicant for the last five years may be sent in a separate envelope if maintained.
